1. Bill No. 1750, Proposed Ordinance No. 1732,

AN ORDINANCE

OF THE CITY OF UNIONTOWN, FAYETTE COUNTY, PENNSYLVANIA,  
ELECTING TO AMEND ITS NON-UNIFORM PENSION PLAN ADMINISTERED BY THE  
PENNSYLVANIA MUNICIPAL RETIREMENT SYSTEM PURSUANT TO ARTICLE IV OF  
THE PENNSYLVANIA MUNICIPAL RETIREMENT LAW; AGREEING TO BE BOUND  
BY ALL PROVISIONS OF THE PENNSYLVANIA MUNICIPAL RETIREMENT LAW AS

SHOWING THE ESTIMATED RECEIPTS, EXPENDITURES, AND LIABILITIES OF  
EVERY KIND OF ALL THE FUNDS FOR FISCAL YEAR 2022 WITH THE BALANCE OF  
UNEXPENDED APPROPRIATIONS AS THE BASIS FOR FIXING THE LEVY AND TAX  
RATE FOR SAID FISCAL YEAR, APPROPRIATING AND AUTHORIZING  
EXPENDITURES OF THE VARIOUS AMOUNTS SHOWN AS PROPOSED  
EXPENDITURES HEREIN FOR THE EXPENSES OF THE CITY FOR SAID FISCAL YEAR  
FROM THE REVENUE AVAILABLE FOR SAID FISCAL YEAR FOR THE  
DEPARTMENTS, BUREAUS, AND SPECIFIC PURPOSES SET FORTH HEREIN, AND  
THE REPEALING OF ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT  
HEREWITH; (THE BUDGET ORDINANCE FOR FISCAL 2022)

3. Bill No. 1754, Proposed Ordinance No. 1734,

AN ORDINANCE

FIXING THE SALARIES PAYABLE BY THE CITY OF UNIONTOWN FOR THE VARIOUS POSITIONS ENUMERATED HEREIN FOR THE FISCAL YEAR 2022, AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT HEREWITH;
