Important Application and Payment Information:

- A \$20 fee is required for each weekly farmers market. Cash payments are not accepted; payment must be made by check or money order payable to City of Uniontown, with "Parks and Recreation Farmers Market" and the date of the market noted in the memo line, and submitted to City Hall at 20 N. Gallatin Avenue, Uniontown, PA 15401. All fees are non-refundable. If payment is not received by 5:00 PM on the Wednesday following the market date, the vendor may be prohibited from participating in future markets. The weekly fee is waived after a vendor has attended and paid for twelve (12) markets.
- Products or services being sold are subject to approval of the Recreation Board of the City of Uniontown.
- Ultimate participation, selection, or approval of vendors, permits, dates, and locations is subject to the discretion and final approval of the Recreation Board, and may be limited due to space or time limitations.
- Tables, tents, and canopies are permitted within allotted space and in accordance with any safety rules.

Specific Rules and Regulations:

- Market runs every Saturday from May 30 to Sep 26 2026 from 9am -12pm at Bailey Park in the parking lot along Pennsylvania Ave. Please arrive early to be set up for the beginning of the market. Vendors must remain for the entire duration of the market.
- Vendors are required to remove their own garbage and/or boxes, etc. A penalty/clean-up fee may be charged for failure to remove such garbage or items.
- The City of Uniontown is not responsible for any lost or stolen items.
